

RESOLUTION NO. 2009-36

A RESOLUTION TO SHARE AND MAINTAIN A COMMUNITY WEBSITE AND OTHER SERVICES BETWEEN THE CITY OF WAYNE, COUNTY OF WAYNE, WAYNE PUBLIC SCHOOLS AND WAYNE AREA ECONOMIC DEVELOPMENT

THIS AGREEMENT is made and entered into by and between the governmental entities which are The City of Wayne, hereinafter called the "City", Wayne County, hereinafter called the "County", Wayne Public Schools, hereinafter called "School" and Wayne Area Economic Development, hereinafter called WAED, which on its effective date are, or become, signatories hereto:

WITNESSETH THAT:

WHEREAS, it is the recognized responsibility of general purpose political subdivisions to provide and maintain a certain basic level of public services for their residents, including the areas of health and public safety, and information services; and

WHEREAS, it is the recognized responsibility of the State College Board of the State of Nebraska to provide and maintain a certain basic level of public services for its student population, including the areas of health and public safety, and information services; and

WHEREAS, it is recognized that the provision of said basic services are sometimes best accomplished jointly because of certain hardships which might be experienced if undertaken singularly, and

WHEREAS, Sections 13-804 through 13-814, Reissue Revised Statutes of Nebraska, 1943, authorized the joint exercise of powers, privileges and authority by agreement of two or more public agencies of any power common to them; and

WHEREAS, these governmental entities do agree that the solution to this problem lies in cooperative action; and

WHEREAS, it is the desire of the parties hereto signed to participate in the joint use of information technology, personnel and law enforcement and resources.

NOW, THEREFORE, BE IT RESOLVED, that the City of Wayne, Wayne Public Schools, Wayne County, and Wayne Area Economic Development hereto signed do agree to the following:

- 1) Community Website: That the City, with agreement from the other three signatories, will serve as the contracting agency and lead agency to purchase and maintain a community website from CivicPlus for the purchase price of \$32,055 plus the annual maintenance fee.

- a. As a part of this agreement, the City will perform the following services as agreed upon by the four parties:

1- Serve as the local contact for CivicPlus; and

2- Perform local daily website maintenance tasks and provide a full-time IT resource person for the community website for the four agencies.

2. Division of Costs:

- a. Purchase Price: The cost of the initial purchase of the community website and training will be shared as follows:

i. City	\$15,055
ii. County	\$ 8,000
iii. School	\$ 5,000
iv. WAED	\$ 4,000

- b. Annual Maintenance Fee: The annual maintenance fee charged by CivicPlus will be shared equally by the four signatories and paid once per year.

- c. Grant Funds Received: Any grant funds received for the initial purchase cost of the community website will be used to reimburse the four signatories in the same ratio as the share of the cost in paragraph 2. a.

3. Agreement Duration: The term of this agreement will be effective beginning _____ and be in effect until such time that any of the four signatories give 3-month written notice to terminate the agreement

4. Agreement Amendments: This agreement may be amended at any time by the written agreement of both parties.

Executed by the City of Wayne, Wayne Public Schools, Wayne County and Wayne Area Economic Development upon the respective dates set forth following the executory signature attached to this agreement.

THEREFORE BE IT RESOLVED, that the County of Wayne does declare itself to be a participant in the joint effort to provide a community website.
